Bidders/ Contractors shall attach scanned copies of all the paper, i.e., copies of the certificates as required in Eligibility criteria given in the Corrigendum/ Addendum/ Corrections/ Revised DNIT, if any will be

published on the website.

5. If the date of opening of tenders happens to be a holiday then the tenders will be opened on the next working day.
6. Bid shall be valid for 90 days after the deadline date for Bid submission.
7. Bidders/ Contractors should have valid GST and PAN registration.
8. Bidders/ Contractors should have valid ESI and EPF registration. In case of unavailability of the same an undertaking should be submitted with the technical bid that ESI/EPF number will be arranged within one month from the date of allotment of work.
