CONDITIONS:

1. Bidders have to pay the Earnest Money Deposit (EMD), Tender Form Fee & Tender processing fee as mentioned above in online mode. EMD can also be paid in the shape of Bank Guarantee, in favor of "Punjab Police Housing Corporation Ltd. S.A.S. Nagar" issued by any scheduled commercial/ nationalized bank, valid for 90 days from the date of submission of bid. In case of offline Bank Guarantee, the bidder would have to deposit original Bank Guarantee 24 hours before opening of PQ/Technical bid in the office of Chief Engineer, PPHC, Phase 7, S.A.S. Nagar.
2. Interested bidders can purchase the tender documents online from website.
3. Pre-bid meeting will be held in the Conference room of PPHC. Bidder can also join on webex Meeting No. 25166167623. **No queries will be entertained after last date and time of submission of Pre-bid queries.**
4. Bidders/ Contractors, who wish to submit online tenders can access tender

documents on the website, fill it and submit the completed tender document into Electronic Tender on the website itself. Bidders/ Contractors shall attach scanned copies of all the paper, i.e., copies of the certificates as required in Eligibility criteria given in the Corrigendum/ Addendum/ Corrections/ Revised DNIT, if any will be published on the website.

5. If the date of opening of tenders happens to be a holiday then the tenders will be opened on the next working day.
6. Bid shall be valid for 90 days after the deadline date for Bid submission.
7. Bidders/ Contractors should have valid GST and PAN registration.
8. Bidders/ Contractors should have valid ESI and EPF registration. In case of unavailability of the same an undertaking should be submitted with the technical bid that ESI/EPF number will be arranged within one month from the date of allotment of work.
9. The quoted rates should be inclusive of all prevailing taxes.
10. The bid submitted by a bidder shall not be accepted, if the bidder has indulged in corrupt or fraudulent practice in the past or has made misrepresentation or has a record of poor performance.
